We operate in the IT sector of the economy and our annual turnover is less than R5 million. The Codes therefore define us as an Exempt Micro Enterprise.


Our BBBEE policy is based on the seven pillars of empowerment and we intend making a meaningful contribution to each pillar where it is feasible
